



#### Mitigation for Lengthy Class II Supply Chain

#### **Material Suppliers**



- Most Class II items are military unique and manufactured to support anticipated demand
- Lead times for items from a cold start can be 180+ days
- Industrial base has extremely limited capacity to quickly surge to meet larger demands
- Accurate usage forecasts <u>by size</u> are critical to maintaining readiness
- DLA primarily business model for Class II items is continuous monthly deliveries for stock and distribution to mitigate supply chain length and lead times

  - Prices can go up and go down




#### **PFAS - Per-and Polyfluoroalkyl Substances**




